**DIRECTIONS:** Hubbard, TX is located northeast of Waco on Hwy 31. From the stop light at the intersection of Hwy 171 and Hwy 31, go 0.6 miles east on Hwy 31 and turn left on North Apple Road. Turn right onto CR3325. Take the first left onto CR3322 Loop and follow it around to the new double-gated entrance on the right. When you go past the Silo, you're almost there. The entrance is approximately 5.1 miles from the Hubbard stoplight. **Remember to stay on CR3322 - the road makes a 90 degree right at the 3.2 mile marker, do not go straight as it is a dead end road.**
